

Collaboration Agreements, Memoranda of Understanding, Letters of Intent (+200) Activities may include joint research, information sharing and exchange of personnel

#### Competitive Activities (+140)

May involve work carried out at JRC facilities + access to the JRC's infrastructure. The aim to form partnerships with major European players

#### Scientific networks (+ 60)

Essential for harmonising and validating methods and measurements, establishing common standards, and providing support for the implementation of EU legislation

Signature of MoU for research co-operation in energy, maritime affairs, food, health environment and security 1 April 2014


