## FIDIBE objectives and Partners

The main objective of our project is to increase the innovative potential and competitiveness of the SEE area via the development and support of competitive and innovative small and medium-sized enterprises through developing and improving support networks and services for innovative SMEs in the area. The project size is Euro: 2.220.000 including ERDF contribution of Euro 1.887.000. 9 Partners from 7 different countries joined the project. Each partner plays a leading role in the field of innovation and business park development in its region and in some cases even at international level.





This project is funded by the European Union and co-funded by the Hungarian Government in the framework of the South East Europe Transnational Cooperation Programme

FIDIBE is the acronym of the "Development of Innovative Business Parks to Foster Innovation and Entrepreneurship in the SEE Area", a project funded by the <u>SEE Transnational Programme</u> and co-funded by the relevant national or regional governments and the Partners themselves.

## Studies of the innovative potential of FIDIBE Partners regions

All project Partners have completed the first major studies of FIDIBE: the "Analysis of the Innovative Potential" of their region.

These studies have been prepared in order to overview:

- the main innovative sectors of the regions, its specific characters general situation and SWOT,
- main actors contributing to the development of innovative capability and entrepreneurship of the region, including the SME policies, the institutional system of innovation support and main support services,
- suggestions and proposals for overpassing the problems identified.

The results of the studies will be integrated in the core output of the project, namely the Innovative Business Park Manual. As soon as all the analyses are completed a summary will be prepared which will include the most important findings of the individual documents: therefore it can provide valuable inputs for the programming of new transnational programmes, as well.

#### Best practice analysis of Innovative Business Parks in the SEE Area

As the next major milestone each Partners of FIDIBE has identified one or more Business Parks in their region or country as being "best practices". With the leadership of the Greek Partner, CERTH, a matrix was prepared to select the "best practices" of the Parks accordingly to different topics and areas (ownership, strategy, services etc). A CERTH-developed common methodology was used to prepare the description and evaluation.

The completed analyses will be continuously uploaded in the <u>Outputs and results</u> section of the website.

#### Manual of the Innovative Business Parks and Best Practice Analysis

The core output of FIDIBE is the **Manual of the Innovative Business Parks** – available in an easily accessible electronic format – which will be a unique document in the SEE area – and hopefully at EU level – concentrating on the following 2 main issues:

- a guideline helping decision-making in terms of 'what' and 'where' what kind of Innovative Business Park should be developed and where,
- what kind of conditions have to be taken into consideration, when developing an Innovative BP (mission, legal structure, fund raising, organisational structure, financial planning, services offered, client selection etc)

The Manual will concentrate on practical examples and will demonstrate the relevant best/good practices from Southeastern-Europe. Each Partner in FIDIBE has collected its regional/national good practices, which will be summarised in this Manual and will provide practical examples upon theoretical solutions Preparation of the Manual started with the involvement of external experts and the entire Partnership. It is text is currently under finalisation. It will be developed in an easily usable electronic form, which will be completed and distributed during autumn 2010. The results of the manual will be presented on an International Seminar in December 2010.

## News from Sviluppo Basilicata

On February 16<sup>th</sup> 2010 Sviluppo Basilicata launched the public "Invitation to submit proposals for projects finalised to the creation and development of Innovative Enterprises to be settled in the Val d'Agri business incubator". 6 proposals were submitted by innovative SMEs and the team of experts – 4 professionals belonging to Sviluppo Basilicata and one more member chosen among the experts on innovation and eco-sustainable energy of the Basilicata Region – selected in order to verify the proposals submitted is currently at work. The official list of the "winning" companies is going to be published at the beginning of September.

Two transnational projects – with the involvement of Sviluppo Basilicata SpA – have received funding in the MED Programme and have been started with the two respective kick-offs on Mid July in Athens: **KnowInTarget** (Lead Partner: Consulting Department of ETAT S.A. – Greece) and **2INS Clusters** (Lead Partner: BIC of Attika – Greece). In June, it was also subscribed the Partnership Agreement for the project **Factor 20** under the umbrella of the Life Plus Programme (Lead Partner: Regione Lombardia – Italy).

# News from Technology Park Ljubljana

## Two new European Projects

Technology Park Ljubljana got approved two European project. First project **PROINCOR** – Proactive Innovation Support for SMEs in the Corridor from the Baltic to the Mediterranean Sea is co-financed by the Central Europe Programme. In three-year program ten project partners are going to prepare the innovation audit tool, which will enhance innovation processes and innovation products in the small and medium sized enterprises. The second project **MED-KED** – Mediterranean knowledge-based entrepreneurship development is co-financed by the Mediterranean Programme. Consortium of five project partners is going in a three year endeavor examine the potential for the enhancement of the knowledge based entrepreneurship environment in the region and provide recommendations and pilot actions for the promotion of the knowledge based entrepreneurship.

## Technology Park Ljubljana took over the Presidency of European Division IASP

Iztok Lesjak, General Manager of Technology Park Ljubljana, was elected President of the European Division of the International Association of Science Parks during the World Conference held in Daejeon, Korea, on 24-26th May 2010.

During his two-year term as European Division President, Mr. Lesjak will serve on IASP's esteemed International Board of Directors, comprised of science park leaders from around the globe.

The International Association of Science Parks (IASP) is an international non-profit association dedicated to assisting the development of new science and technology parks as well as the growth and internationalisation of already mature projects, encouraging partnerships and fostering international networking among nearly 400 member organisations, represented by over 70 countries.

The Technology Park of Ljubljana is an active member of IASP since July 1997. Presidency of the European Division IASP will complement the Park's vision of becoming an internationally recognised support environment and commercial centre for the flourishing of globally competitive innovative entrepreneurship.

## News from Business Innovation Centre of Croatia

## BICRO launches co-financing program for researchers and entrepreneurs

Business Innovation Center of Croatia, in cooperation with partners, aims to provide initial co-financing for innovative research and entrepreneurial projects via Proof of Concept program

ZAGREB, May 2010 – Business Innovation Center of Croatia (BICRO), in cooperation with Technology Transfer Office at the University of Zagreb, Science and Technology Park (SteP Ri) at the University of Rijeka, Technology park Varaždin, Tera Tehnopolis, and Regional Development Agency Međimurje (REDEA), launched a Proof of Concept (PoC) program. The initiative will provide non-refundable financing options valued between HRK 35,000 and HRK 350,000 per project in order to facilitate verification and protection of intellectual property and demonstration of practical technical feasibility. Along with core activities, the funds will also be used for conducting market analyses, business planning, concept and strategy development in product commercialization, as well as providing business support in establishment of market feasibility of new ideas. The program provides funding of up to 75 percent of the total expenses, whereas the remaining 25 percent will have to be secured by the companies participating in the project – either by their own devices or via third-party sources. The Proof of Concept program aims to establish methods of measuring technical characteristics and commercial potential of the research output in order to close the gap between research and development and commercial markets.

# BICRO invests 3.5 HRK million in development of research and business incubator in Osijek

ZAGREB, July 2010 – The contract on financing the founding of research incubation and business center "TERA Osijek" was signed at BICRO premises during the month. The initiative, carried out within BICRO's technology infrastructure development program TEHCRO, will secure HRK 3.5 million for support – 32 percent of the total project cost. The project is a part of the technology transfer and public research commercialization system built by the University of Osijek, and with cooperation and participation of local authorities. All participating parties are either providing support by funding or physical assets and are actively involved in business operation of TERA TEHNOPOLIS trading group.

The support extended toward development of research and business incubator represents the continuation of TERA TEHNOPOLIS activities: expansion of the available business space from existing 1,200 to 3,000 square meters (translocation to a new location in Tenja, Tehnopolis Osijek premises), and development of the existing organization. The new organization will provide support in a form of subsidized service packages tailored for specific client needs. From 2007 to the present day the Croatian government invested more than HRK 172 million into innovation and technology-based entrepreneurship via a dedicated development program.

## BICRO invests HRK 770 thousand into innovative violin

ZAGREB, July 2010 – A new contract was signed at BICRO premises in Zagreb during the month. The project, carried out as a part of the program for development of the knowledge-based companies (RAZUM), aims to provide company VŠP from Varaždin with funding of up to HRK 770,000, nearly 70% of the total project cost.

The project includes development of the new violin chinrests. This innovation enables optimal ergonomics and easier adaptation to individual musician's needs, in addition to lowering the total weight of the instrument. The purpose of this project is to provide a new innovative market product that does not damage the violin body, and at the same time contributes to better instrument's performance. This advanced solution resolves nearly all shortcomings of the conventional chinrests.

#### **BICRO** presents Manual for Business Innovation Parks

ZADAR, July 2010 – At the conference held in the hotel Kolovare in the town of Zadar experts from the Business Innovation Center of Croatia, together with FIDIBE partners, presented the first draft of the Manual for Business Innovation Parks. The aim of the document is to provide help in development and maintenance of innovative parks. It is based on a select set of best practices collected from countries participating in the FIDIBE project which are further expanded by regional political, economic and cultural particularities. The Manual is one of the FIDIBE project deliverables and is to a large extent based on Study on Innovation Potential that was conducted in participating support for innovative business parks in Southern and Eastern European countries, BICRO that has been actively working on TEHCRO, a government program for financing Croatian research sector and innovative infrastructures, secured additional resources for further advancement of new centres and other complementary components necessary for continual and sustained growth of Croatian economy, knowledge and innovation.

## News from Mid-Pannon Regional Development Company

Mid-Pannon participate as a consultant in several ERDF-funded town rehabilitation project: preparation of the social town rehabilitation project of Veszprém and Székesfehérvár towns has been launched, town rehabilitation projects of Székesfehérvár, Tapolca, Balatonfüred and Komarom have been approved by the Regional Development Agency (total project volume is appr. euro 20 million). Mid-Pannon provides project management for the ice-hockey stadium reconstruction of the hockey stadium of the town of Székesfehérvár.

Mid-Pannon also participates in a number of other transnational projects related to clusterization:

The Clusters-Cord project (2CE202PI) is one of these supported initiatives established by a Central European consortium. The project is a transnational cooperation project supported by the Central Transnational Programme, since it aims at jointly looking for answers to improve regional capacity in the management and development of clusters, through the exchange of experiences and good practices and development of direct cooperation among existing actors, as a sustainable result of the project.

Support of creating of meta-clusters in key industries in sustainable way is very efficient way to increase the competitiveness of Central Europe. The lead partner of the project is the Regional Development Agency of Usti Region, PLC; Mid-Pannon is one of the Work Package leaders, as the main responsible partner for research & transfer of experiences and good practices. All the Central-Transdanubian Solar Energy Cluster, the Pannon RDI & Educational Cluster and the Central Transdanubian ICT Cluster have been involved in the project.

The Mid-Pannon Team is a WP-Leader in another cluster-project supported by the Central Transnational Programme, too. The partners in the AutoNet (2CE201P1) project, leaded by the Automotive Cluster – West Slovakia, agreed on the establishment of permanent network of leading automotive regions in CE. The project has been focused on 3 major areas by realization of common activities through the network:

- search or research of new services they could be provided by supporting actors in region to improve the conditions for innovation
- boost creation of transnational cooperation or ventures to produce innovative solutions
- create awareness about supporting of innovation in the automotive at different policy decision maker levels by elaboration of policy recommendation at 3 levels (regional, national and EC) and realize implementations through associated institutions of project

The Automotive and Mechatronic Cluster of Ajka, as the lead automotive cluster in Central Transdanubia, has been involved in the implementation.

## News from Harghita County Council

#### Kick-off a new project

A new INTERREG IVC project called ROBINWOOD PLUS is started in April with the partnership of the Harghita County Council. Main objective of the project is the promotion of the multifunctional role of forests as engine for economic development, environment protection and quality of life improvement in rural areas, in accordance with the eu Forest Action Plan and sustainability policies.

# Traditional Szekler products on the international market

Since 2008 Harghita County Council initiated a program in order to promote and sell traditional Szekler products on foreign markets. Initially, these products were promoted through presentations and by participating at exhibitions and fairs organized in Hungary. The negotiations with the Cora Hypermarket Chain were successful, and it made possible the organization of a successful product presentation and tasting event called Szekler Weeks in the Cora hypermarkets in Hungary from 7<sup>th</sup> till 22<sup>nd</sup> of May 2010. Based on this success, a new Committee was established for the approval of Szekler products trademark, making a step closer to the possibility of trade and promotion of traditional and renowned Szekler products on international level.

# News from VEGA - VEnice GAteway for Science and Technology

## "University master on Brownfield's characterization and rehabilitation"

A second-level university master on "Brownfields' characterization and rehabilitation" will be held in VEGA from October 2010 to October 2011. Proposed and promoted by the Environmental Department of Ca' Foscari (University of Venice), it foresees 35 places.

The master will be structured in lectures, seminars, laboratories, on-field tutorials, cases of study and stages within local enterprises.

The master is sponsored by the City of Venice, the Province of Venice, the Regional agency for the prevention and protection of the environment and it's realised thanks to the cooperation of Venice's local organization of industries, VEGA park and other local associations.





## **VEGA** in Shanghai

On the 26th of May, 2010, the mayor of Venice has inaugurated the Venice's pavilion of Shanghai word expo.

The city's different institutions, local authorities and private and public subjects have decided to present, during this worldwide event, some of the most important projects that have transformed the ancient city as well as the mainland.

Regarding the mainland, VEGA is one of the most important examples of the interventions realised during the last decade. The future of Marghera and the rehabilitation of the Waterfront, of which VEGA is an important part, has been presented too.

## Co-working is VEGA has been launched

There are people that share the flat in order to divide the costs, people that look for someone to share the oil for a long car trip, people that look for colleagues. During the economic crisis it's not only difficult to pay the entire rent for an office, but it's also hard to take profit of the occasions. In a world where, generally, who has ideas ha no money, is born the co-working. "A physical space where everybody may have at their disposal an internet connection, a desk, and the tools to implement its work. And, over all, where young brains and entrepreneurs may meet and exchange ideas" says VEGA director, Michele Vianello. Each co-office in VEGA costs 250 euro per month but there are different formulas of renting: it's possible to rend the office only for one day!

VEGA it's the first example of co-working in Italy.

#### The industrial park next to Mosonmagyaróvár is attracting more companies

More and more companies are interested in the possibilities provided by the industrial park next to Mosonmagyaróvár, in the western borderregion of Hungary.

Industrial Logistic Business Park Ltd. has just finished its project focusing on the development of investment environment of local industrial park. The Industrial Logistic Business Park Ltd. supported this program with more than 198 million forint, the rest of the budget was provided from West-Pannon Operative Program.

The investor has adapted the infrastructural conditions for the enterprises' needs who show increasing interest in the park due to its very special location near the Budapest-Vienna line.

#### Taiwanese Investor began building a Factory

Friday, April 16 2010, after laying the corner stone, a Taiwanese company, AU Optronics, launched the construction of its LCD monitor production facility located in the city's industrial park zone A ceremony hosting almost two hundred guests was opened by the Taiwanese delegation headed by the AU Optronics Vice President - Fred Hsieh, the Minister of Economy, Lubomír Jahnátek, and the Mayor of Trenčín, Branislav Celler.

The facility that will specialize on the production of the TFT LCD module, back light units, as well as television sets in the hi-tech area, is to be completed by the end of the year. Third largest world producer of liquid crystal monitors plans to launch full operation as early as the beginning of next year. This 191-million-Euro investment of the company based in Taiwan is to generate 3,300 new jobs. A few days ago the company AU Optronics already started the process of selecting new workers.
