REQUIRED DOCUMENTS TO BE SUBMITTED

- 1. Proposal for services contract (attached)
- 2. Detailed Curriculum Vitae (CV)
- 3. Copies of University degrees or diplomas, certifications and certificates of prior experience or employment, as well as and any other document that substantiates the required qualifications and those listed in the CV.

Qualifications listed either in the proposal or in the CV, which are not documented by the submission of the relevant documents shall not be considered and shall not be graded for the final ranking of candidates.

Male applicants must have fulfilled their military obligations or legally be exempted from them throughout the contract term (if applicable).

Proposals will be considered only if they are submitted or sent in a sealed envelope and received by CERTH/IRETETH, under the responsibility of the applicant, by May 27th 2015 at 14:00 hours, at the latest, in the following address:

The objection can be either submitted in person or sent by registered mail or courier directly to CERTH / Institute for Research and Technology Thessaly (IRETETH) (Dimitriados 95 & Pavlou Mela, GR 383 33, Volos, Greece) and must be received by CERTH / IRETETH, under the responsibility of the objecting candidate, within the period of 5 days.

The envelope of the objection must be clearly marked on the outside with the following:

The candidate's identity (name, address, phone number).

Any objections received after this deadline will be rejected as belated and they will not be assessed.

Candidates have the right to access their documents as well as at those of other candidates upon a written request and subject to the conditions of Article 5 of Law 2690/1999 (Φ EK A' 45/9.3.1999). Access rights to the evaluation records of other candidates, can be exercised in favor of the applicant, subject to the compliance with the requirements in items Γ /E=/4163-1/06.07.2012 document of the Hellenic Data Protection Authority, namely when he/she has a legitimate interest to defend his/her rights before the competent courts.

EVALUATION OF PROPOSALS – OTHER TERMS AND CONDITIONS

- **1.** From the proposals that are submitted by the deadline set and according to the aforementioned terms and conditions, the one deemed most appropriate is selected and a contract is concluded with the selected candidate, based on the principle of contractual freedom.
- **2.** Those proposals received within the prescribed period are considered valid. In case of registered mail delivery or courier service, CERTH shall not be liable for the time of delivery and the content of the file of the proposal sent.
- **3.** Replacement of the proposal, correction or completion of any missing document is allowed only up to the deadline of submission of proposals.
- **4.** If the university degrees (undergraduate or postgraduate) that are a prerequisite (of this call) have been awarded from a foreign university or institution, they must be accompanied

by a certificate of recognition issued by the Hellenic National Academic Recognition and Information Center (DOATAP – Hellenic NARIC).

- **5.** It should be pointed that the process of the present call for proposals for conclusion of a contract under private law do not constitute a tendering procedure, while, in case of selection of candidate/counterparty, it qualifies as acceptance of a proposal for conclusion of contract rather than hiring (of the candidate/counterparty). The process of the present call of interest will be concluded by drawing a rank order list and all the selected candidates will be informed individually.
- **6.** A submitted proposal that does not fulfill the requested qualifications in the call of interest is not assessed and therefore is rejected.
- **7.** The award of contract shall be made in accordance with the provisions in the Project Implementation manual.
- **8**. During implementation of the project and in case a candidate needs to be replaced, he/she will be replaced by another candidate in the framework of this call and in accordance with the rank order list.
- **9.** If, for any reason, the project funding is discontinued, CERTH reserves the right to terminate the contract signed, without penalty, after a written notice of termination.
- **10.** CERTH assumes no obligation to conclude a contract, given that it is in its complete discretion to conclude a contract or not, as well as the number of them, excluding any rights of the candidates for any claims.
